The Commission on Disability (COD) provides information and consultation to citizens of Wilbraham with disabilities and their families. The Commission advises and assists town officials in ensuring compliance with federal and state disability laws. Its members work with the town's building inspector to survey public buildings and monitor compliance with federal and state ADA standards. The Commission is also concerned with employment policies and procedures, parking facilities, recreational access, publication of town reports and other accommodation issues for the disabled.

The COD receives its funding from fines assessed against handicapped parking violations and gifted donations. These funds may be used for grants or scholarships to Wilbraham-based organizations, programs, schools, and individual residents. The goal of these awards is to ease the burden of the costs associated with the services, equipment, education, training, and other expenses incurred by persons with disabilities.

This form may be used to submit a request for grant or scholarship funding to the COD. Please note that applications are considered as they are received and are subject to the availability of funds. Decisions regarding each grant application may take ninety (90) days. As part of the evaluation process, the requesting party may be asked to make a short oral presentation before the COD at a regularly scheduled meeting. Additionally, as the COD considers this request, they reserve the right to request additional information.

Please note that material submitted to the COD may be public record and are not confidential. Please do not submit personal and/or medical information or documentation with applications.
