

# WARRANT

SPECIAL TOWN MEETING, OCTOBER 23, 2023

TO ANY OF THE CONSTABLES OF THE TOWN OF WILBRAHAM IN THE COUNTY OF HAMPDEN,

Greetings:

In the name of the Commonwealth of Massachusetts you are hereby required to notify and warn the inhabitants of Wilbraham qualified to vote in Town affairs to meet at **7:00 PM, on Monday, the 23<sup>rd</sup> day of October, 2023, at Minnechaug Regional High School Auditorium**, in said Town, then and there to act on the following articles:

**ARTICLE 1. Transfer of Free Cash for Capital Improvements to the HVAC System at Minnechaug Regional School.** To see if the Town will vote to transfer a sum of money from Free Cash to be used for expenses relative to Capital Improvements to the HVAC system at Minnechaug Regional High School; or take any other action relative thereto.

*Explanation:* This Article proposes transferring funds from Free Cash for Wilbraham's share of the cost of improvements to the HVAC System at Minnechaug Regional High School, as follows: Boiler Heat Exchange, \$100,082.15. Hampden's share is: Boiler Heat Exchange, \$24,917.85. Total Project Costs: Boiler Heat Exchange, \$125,000.

**Finance Committee Recommendation:** Finance Committee to Make Recommendation at the Special Town Meeting.

**ARTICLE 2. Transfer of Free Cash for Capital Improvements to the HVAC System at Minnechaug Regional School.** To see if the Town will vote to transfer a sum of money from Free Cash to be used for expenses relative to Capital Improvements to the HVAC system at Minnechaug Regional High School; or take any other action relative thereto.

*Explanation:* This Article proposes transferring funds from Free Cash for Wilbraham's share of the cost of improvements to the HVAC System at Minnechaug Regional High School, as follows: AC Split Units for IEP Needs, \$24,019.72. Hampden's share is: AC Split Units for IEP Needs, \$5,980.28. Total Project Costs: AC Split Units for IEP Needs, \$30,000.

**ARTICLE 3. Transfer of Free Cash for Capital Improvements to Technology at Minnechaug Regional School.** To see if the Town will vote to transfer a sum of money from Free Cash to be used for expenses relative to Capital Improvements to Technology at Minnechaug Regional High School; or take any other action relative thereto.

*Explanation:* This Article proposes transferring funds from Free Cash for Wilbraham's share of the cost of Technology improvements at Minnechaug Regional High School, as follows: Classroom Projectors/Monitors, \$43,235.49. Hampden's share is: Classroom Projectors/Monitors, \$10,764.51; Total Project Costs: Classroom Projectors/Monitors, \$54,000.

**Finance Committee Recommendation:** Finance Committee to Make Recommendation at the Special Town Meeting.

**ARTICLE 4. Transfer of Free Cash for Capital Improvements to Technology at Minnechaug Regional School.** To see if the Town will vote to transfer a sum of money from Free Cash to be used for expenses relative to Capital Improvements to Technology at Minnechaug Regional High School; or take any other action relative thereto.

*Explanation:* This Article proposes transferring funds from Free Cash for Wilbraham's share of the cost of Technology improvements at Minnechaug Regional High School, as follows: Camera System Updates, \$60,049.29. Hampden's share is: Camera System Updates, \$14,950.71. Total Project Costs: Camera System Updates, \$75,000.

**Finance Committee Recommendation:** Finance Committee to Make Recommendation at the Special Town Meeting.

**ARTICLE 5. Transfer of Free Cash to Reduce the Property Tax Rate.** To see if the Town will vote to transfer a sum of money from Free Cash to be used to reduce the property tax rate; or take any other action relative thereto.

*Explanation:* This Article proposes transferring funds from Free Cash to reduce the Property Tax Rate. The Finance Committee will recommend an amount to be transferred at Special Town Meeting.
